## **Quarterage for the Livery Year Beginning 30<sup>th</sup> September 2014 – Invoice to Pay**

***Please note you will not receive a separate invoice and that this letter should be taken as such***

At the July 2014 Court meeting it was agreed that the full Quarterage rate for the forthcoming year should be set at £350.00 including VAT (where applicable). Accordingly the new rates are:

Full Membership	<b>£350.00</b> including VAT of £58.33
Veteran: Post 1 <sup>st</sup> October 2008 (75%)	<b>£262.50</b> including VAT of £43.75
Emeritus/Veteran: Pre 1 <sup>st</sup> October 2008 (50%)	<b>£175.00</b> including VAT of £29.17
Young Entry Scheme (50%)	<b>£175.00</b> including VAT of £29.17
Freeman (50%)	<b>£175.00</b> including VAT of £29.17
International (25%)	<b>£87.50 (UKP)</b>

Please note that to qualify for the 50% Veteran rate you must have been a Liveryman for 20 years and reached the age of 70 before the 1<sup>st</sup> October 2008. After that date you must have been a Liveryman for 30 years and reached the age of 80 to qualify for the 50% rate. To qualify for the 75% rate you must have been a Liveryman for 25 years and reached the age of 75 years after 1<sup>st</sup> October 2008. The Young Entry Scheme includes all Liverymen up to the age of 40. The "International" category covers all Liverymen living overseas outside the United Kingdom, Isle of Man and Channel Islands. To help reduce cost increases much greater use of electronic communication is now being used. If you haven't got an internet connection and an e-mail address, please consider getting one and start using the Company website, [www.plumberscompany.org.uk](http://www.plumberscompany.org.uk). It will make keeping in contact with you much quicker, easier and cheaper.

**For those Liverymen for whom we have Direct Debit Instructions the appropriate sum will be collected on 1<sup>st</sup> October 2014. For those who pay by cheque, please make it payable to "The Worshipful Company of Plumbers" and forward to the office by 30th September 2014. International members are also asked to pay by International bank transfer by 30th September 2014.**

If you are uncertain into which category you fall, please telephone the office. Also, if you currently pay by cheque, this adds to our costs and we would like all quarterage to be paid by Direct Debit. Please contact the office and we will send you the necessary forms.
